- Administration Officer - The person/s employed by Arboriculture Australia to conduct administration on its behalf.

4 Process Detail

Arboriculture Australia will place limits on the information it holds when the information:

- is commercial in confidence
- concerns the privacy of its members, staff, volunteers or sponsors
- requires protection to safeguard the intellectual property of the organisation.

You shall not, either during or after your time on a committee of Arboriculture Australia, without the prior consent of the Arboriculture Australia directly or indirectly, divulge to any person or use the confidential information for your own or another's benefit.

To protect this information, a Committee Chair or a Committee member shall be required to sign a confidentiality agreement (See Appendix 1)

Unauthorised disclosure of confidential or privileged information is a serious violation of this policy and will subject the person(s) who made the unauthorized disclosure to appropriate discipline, which could result in removal from the position held.
